



## How do I apply to vote by proxy?

- 1** You must ask someone if they are willing and able to be your proxy and vote on your behalf. Please note that a person can only be the proxy for close relatives and up to two other people at the same election or referendum\*.
- 2** Fill in the proxy vote application form.
- 3** Make sure **you** complete all sections of the form and supply your date of birth and signature.
- 4** Return your form as soon as possible to the address shown below.

From 10 June 2014 in England and Wales, and from 19 September 2014 in Scotland, only electors who are (or will be) registered individually are entitled to vote by proxy. In addition, the person you wish to appoint as your proxy can only act as proxy if they are (or will be) registered individually. Contact your electoral registration office for further information.

Please **do not** return your form to the Electoral Commission. **Please note:** your application form must arrive at your electoral registration office by **5pm 11 working days** before an election or referendum when changing or cancelling an existing proxy, postal or postal proxy vote and by **5pm 6 working days** before an election or referendum when applying for a new proxy vote. If you are eligible to vote in the Scottish Independence Referendum taking place on 18 September 2014, the deadline to apply to vote by proxy is **5pm on 3 September 2014**.

\* By referendum we mean: Neighbourhood Planning Referendums, Council Tax Referendums, Mayoral & Governance Arrangements Referendums, Local Authority Advisory polls and the Scottish Independence Referendum. If you wish to apply to vote by post for a different type of referendum, please contact your Electoral Registration Officer.



## Voting by proxy

You can apply to vote by proxy for a particular election or referendum, for a set period of time or for all future electoral events. This form allows you to vote by proxy for as long as you remain registered as a Crown Servant, British Council employee or their spouse or civil partner.

## What happens after I've returned this form?

- Your proxy must go to **your** local polling station to vote. If your proxy cannot get to the polling station, they can apply to vote for you by post. They can apply to do this by 5pm **11 working days** before polling day. They should contact the electoral registration office for more details.
- Your proxy will be sent a proxy poll card, telling them where and when to vote on your behalf.
- You should let your proxy know how you want them to vote on your behalf, for example, which candidate, party, or outcome.
- If it turns out that you are able to go to the polling station on polling day, you can vote in person as long as your proxy has not already done so or has not applied to vote for you by post.
- You will need to give your date of birth and signature on this application form. This information is needed to prevent fraud. If you are unable to sign this form, please contact your Electoral Registration Officer.

## Voting as a proxy

A person can only be a proxy for close relatives and up to two other people at an election or referendum.

Close relatives are the spouse, civil partner, parent, grandparent, brother, sister, child or grandchild of the applicant.

The person you wish to appoint as your proxy can only act as proxy if they are 18 or over and they are (or will be) registered individually. The requirement to be registered individually applies from 19 September 2014 in Scotland. For the Scottish Independence Referendum, a proxy does not have to be registered to vote, but must be 16 or over on the day of the poll, and must be a British, Irish, other European Union or qualifying Commonwealth citizen.
