<p>Contracts</p> <p>Any contract which is made between Newchurch Parish Council and either: a) you; your spouse; or your partner; or b) firm in which either you or your spouse or partner is a business partner; or c) a body corporate of which you or your spouse or partner is a director; or d) a body in which you or your spouse or partner has a beneficial interest (that is a firm in which you or your spouse/partner is a business partner or a corporate body in which you or your spouse/partner is a director or an industrial and prudent society where you or your spouse or partner are a member of the management committee or a corporate body in which you or your spouse/partner have a beneficial interest in its securities (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.</p>
