Results of Referendum

A referendum asking 'Do you want Isle of Wight Council to use the Neighbourhood Plan for Brighstone Parish to help it decide planning applications in the neighbourhood area?' was held in the parish of Brighstone on 15 September 2016.

The result of the referendum was:

- Yes 293 (90.43%)
- No 31 (9.57%)
- The turnout was 22.56%.

Following the positive result in the referendum, the Isle of Wight Council 'made' (brought into force) the Brighstone Neighbourhood Development Plan as part of the Isle of Wight Council's development plan on 19 September 2016.
