- One copy of this notice should be completed and submitted with plans and particulars indicating the works proposed to secure compliance with the Building Regulation, which were in force at the time the work commenced.
 - Subject to certain exceptions where Part B (Fire Safety) imposes a requirement in relation to building work a further two copies of the plans should be deposited
- A Regularisation application must be accompanied by the appropriate charge, which is set at a rate of 150% of the normal charge payable.
 - The appropriate charge is dependent upon the type of work carried out. Current scale of charges and methods of calculation are set out in the Guidance Notes on Charges, which is available on request.
